## **Modern Slavery**

Modern slavery is mostly a hidden crime, and to get a true picture of prevalence is very challenging. It is an umbrella term and can include:

human trafficking; slavery, servitude, and forced or compulsory labour.

Identified potential victims to the year ending March 2019 were from over 100 different countries of origin. The <u>same statistics</u> also identify that children under the age of 18 made up around 45% of referrals to the <u>National Referral Mechanism</u>. Examples in relation to children and young people include county lines, sexual exploitation and labour exploitation.

Safer Internet Day is celebrated globally in February each year to promote the safe and positive use of digital technology for children and young people, and to inspire a national conversation about using technology responsibly, respectfully, critically, and creatively. Safer Internet Day 2022 is on 8th February and will be celebrated with the theme 'All fun and games? Exploring respect and relationships online'. Coordinated in the UK by the UK Safer Internet Centre, Safer Internet Day is celebrated in over a hundred countries coordinated by the joint Insafe/INHOPE network, with the support of the European Commission, and national Safer Internet Centres across Europe.

# Talking to your child about online sexual harassment: A guide for

# parents

This guidance is based on the voices of young people giving adults their tips on how to tackle this subject.

The overriding message you'll see from our focus group is **talk early, talk often**. You might be surprised how early our young people felt parents need to start the conversation. But children want an age-appropriate conversation that evolves over time in line with their growing maturity.



#### Whisper: Anonymous Reporting Tool

You can't keep children safe if you don't know what's happening. Anonymous reporting reaches those who are reluctant or find reporting bullying, abuse, grooming or other issues difficult.

Whisper allows your school community to report issues to you. They can choose to be anonymous, or to leave contact details. You can then act more quickly.

Whisper comes with a custom button, link or code for your school website or newsletter, and a unique dedicated mobile number for SMS reporting.

Our focus is on providing advice about all types of harm online and signposting users to the correct services, highlighting to the public a reporting route for non-criminal content. Where the response from industry isn't what was expected, we can follow this up directly.
